1. Payment Terms

- 1.1. Invoices will be issued annually on September 1 via email.
 - 1.2. Pricing is guaranteed for the duration of the agreement.
 - 1.3. All payments are due within 30 days. Multi-year agreements are billed annually at 1/3 of the total cost of the term.
 - 1.4. If payments remain outstanding for 90+ days, advertising materials may be removed. Removal does not waive payment obligations.
 - 1.5. Invoice payments can be made via eTransfer or cheque (details provided upon invoicing).

2. Advertising Material & Installation

- 2.1. All advertising materials are to be provided by the sponsor at the sponsor's expense and must meet the criteria specified by Carstairs Curling Club. The Carstairs Curling Club can provide a list of preferred manufacturers of advertisements upon request.
 - 2.2. All advertising materials will be installed and removed by the Carstairs Curling Club at no additional cost. Any damages incurred during installation or removal will be the responsibility of Carstairs Curling Club.
 - 2.3. While the agreement is in effect, all installed advertising materials will remain the property of the Carstairs Curling Club.

3. Agreement Renewal & Termination

- 3.1. Carstairs Curling Club will notify sponsors of renewal options prior to the agreement's expiry.
- 3.2. The Carstairs Curling Club will reserve your chosen sponsorship package until expiry, and unless the agreement is renewed, the included advertising space will be made available to other sponsors.
- 3.3. If the agreement is not renewed, all advertising materials will become the property of the sponsor, provided all invoices have been paid in full. The sponsor must arrange to pick up the advertising materials from the Carstairs Curling Club. If advertising materials are not picked up within 90 days of the agreement expiry, the advertising materials will become the property of Carstairs Curling Club.
- 3.4. The Carstairs Curling Club reserves the right to cancel this agreement without notice. Should Carstairs Curling Club cancel this agreement, all advertising materials will become the property of the sponsor. A prorated refund will be provided based on the time from cancellation to the next invoice or agreement renewal, whichever is shorter. Any remaining years on the agreement will be cancelled, and no further invoices will be sent.
